Board Meetings

The Culture Club is available to all CCRC agency directors and staff. Members will meet bi-monthly to hold a community-oriented brave space focused on shifting monocultural mindsets to progressive intercultural adaptability for an improved understanding of Diversity, Equity, Inclusion, and Belonging (DEIB). DEIB Leadership Initiative

This is an initiative dedicated to the development of an intercultural mindset along with bias reduction training. The audience is comprised of CCRC Directors, Executive Directors and/or Board Members, who have committed annually to participate in quarterly themed group meetings centering cultural humility, empathy, curiosity, and courage through leadership. Registration details and dates/times for all sessions (held twice per quarter) will be sent directly to CCRC Executive Directors. CCRC agency members holding supervisor or management roles are strongly encouraged to register with or in place of CCRC Executive Directors.

Learning Café Series

Learning Cafés are a series of educational forums that provide actionable steps for the audience to apply in their respective roles and responsibilities. The Learning Café is an intentional effort to introduce our network to expert speakers presenting on a wide range of topics designed to support participant interests. Learning Cafés are held on the second Thursday of each month from 12 - 1pm and are open to the public. Dates may be subject to change based on speaker availability. LGBTQIA+ Affinity Group

Lyndon Cudlitz (Consulting, Education & Training) will be the lead consultant facilitating discussion on the joys, challenges, and nuances of the group's work, identities, and communities. We will hold four quarterly direct community support group sessions specifically for LGBTQIA+ members throughout the year, as well as two allyship sessions each quarter that are open to anyone committed to learning, supporting, and growing in their allyship along with members of our LGBTQIA+ community to fellowship together.

ABOUT INFANT & TODDLER AND INFANT EARLY CHILDHOOD MENTAL HEALTH CONSULTATION

The Infant & Toddler (IT) and Infant & Early Childhood Mental Health (IECMH) Consultation Teams focus on providing specialized support and training for professionals working with children from birth to three years old and birth to five years old. These stages of development are critical, as they lays the foundation for lifelong learning, behavior, and health. The services offered by this team aim to enhance the tools for the CCRC network. These teams provide support to Infant & Toddler Specialists and Infant & Early Childhood Mental Health Consultants at CCRC agencies who work with providers to meet the unique needs of infants and toddlers, equipping them with the skills required to foster optimal development during these formative years.

Data Quality Improvement (DQI)

Data Quality Improvement Meetings occur monthly, directly following the monthly I&T calls. This meeting time serves as an open space to go over concerns and updates to the MITCH database. Dates: 1/29, 2/5, 5/1, 7/10, 8/7, 10/9 & 11/6

DECA Training

The Devereux Early Childhood Assessment Program for Infants and Toddlers (DECA I/T) is a strength-based assessment and planning system designed to promote resilience in our youngest children, 4 weeks up to 3 years old. The DECA I/T Program is implemented using a five-step approach, which includes: (1) collecting information on individual children, the home, and the group care environment, (2) administering the DECA I/T, a strength based assessment of social and emotional development, (3) summarizing assessment results, (4) developing and implementing plans for children who have concerns and for building quality environments, both in the home and group care settings, and (5) evaluating progress.

Infant & Toddler Lead Agency Calls

ECLC hosts quarterly calls to support the I&T Regional Lead Agencies across the state. These meetings provide updates, support and continued collaboration throughout the I&T Network. Dates: 2/19, 6/18, 8/20, 10/8 & 11/5

Infant & Toddler MITCH Office Hours

ECLC will hold open office hours to support the Infant & Toddler Data Collection project beginning in 2025. From January to March, these meetings will be held bi-weekly. Monthly Infant & Toddler Meeting Calls

The Infant & Toddler (I&T) Specialist Monthly Meetings are held on the first Thursday of each month. The goal for these meetings is to provide a space for sharing regional and statewide updates, sharing resources and strategies on a variety of Infant/Toddler specific topics, and for ECLC to provide support to the IT network. Teaching Pyramid Infant–Toddler Observation Scale (TPITOS)

Data Quality Improvement Meetings

IECMH Data Quality Improvement Meetings occur monthly, with IECMH Consultants and Supervisors. This meeting time serves as an open space to go over concerns and updates to the database.

Reflective Supervision

To support supervisors in engaging in reflective practice with IECMH consultants, IECMH Program Director and Reflective Supervisor, Jillian Scanlon, provides individual support to supervisors as they uplift Reflective Supervision Groups in their regions. Jillian's work with supervisors is meant both to deepen their understanding of reflective practice through a parallel process and to provide supervisors with hours towards endorsement.

Trauma Advisory Group - Book Study

The Trauma Advisory Group is a space for CCRC Staff and our Early Education Partners to explore resources regarding Trauma Informed Practices. The group will be utilizing a book study format in 2025, reading "The Deepest Well: Healing the Long-Term Effects of Childhood Adversity" by Nadine Burke Harris. These meetings occur monthly on the last Wednesday of each month from 3:00pm-4:00pm.



IT/IECMHC JOINT MEETINGS

Fall/Spring Retreats

ECLC provides two annual in-person statewide I&T conferences, one in the spring and one in the fall. These events provide the IT Specialists and IECMH Consultants an opportunity to foster collaboration and networking, as well as to attend professional development and training sessions geared towards supporting their respective roles. Quarterly Joint I&T/IECMH Meeting

IECMH Consultants, I&T Specialists, and I&T/IECMH Supervisors gather to brainstorm collaboration between the specialists and the consultants. This meeting occurs once per quarter.

Zero to Three (ZTT) Training

Advocacy Day

Data Round Tables

Annual meetings are held to talk about data topics that affect the whole network and data issues that are regionally specific. Topics could include updates or potential enhancements to the Empire State Child Care MATCH, data trends, or regional updates. This year six roundtables will take place — Regions 1 & 2, Region 3, Region 4, Region 5, Region 6 and Region 7.

Quarterly Data Advisory Committee Meeting

Quarterly meetings for the data advisory committee are held for a group of data admins from around the network that represent all seven regions and various sized CCRCs. Meetings are meant to discuss any issues, concerns, or updates with the Empire State Child Care MATCH database, as well as other data topics.

Resource & Referral Specialist Meetings

Resource and Referral Specialists help parents locate and choose quality child care by providing referrals to local child care providers, information on state licensing requirements, availability of child care subsidies, and other information. Quarterly meetings are held to help resource & referral specialists with any questions or concerns that they have about referral trends, barriers to referrals, using the Empire State Child Care MATCH system, or any issues that they may be having in their region. ABOUT BUSINESS NAVIGATOR

By providing a clear framework of options and actionable steps for decision-making, the Business Navigator Child Care Toolkit meets business leaders where they are today and equips them with impactful child care solutions that drive both business and employee growth. Businesses of all sizes will find practical solutions within this guide that can be implemented right away, and live launches are being provided throughout the state of New York.

The free Business Navigator Child Care Toolkit was created by ECLC's Strategy & Vision Department in partnership with CCRCs across all 10 Regional Economic Development Councils (REDCs) and funded by OCFS. ADDITIONAL SPECIALIZED GROUPS

CACFP Specialists

CACFP Specialists are CCRC staff members who assist in the promotion of the Child & Adult Care Food Program (CACFP) and connect child care programs with resources and opportunities. This group meets quarterly to discuss updates in CACFP, share best practices, and provide resources. Dates: 1/15, 4/16, 7/16 & 10/15

Health Care Consultants

All CCRC employed Health Care Consultants (HCCs) meet quarterly. HCCs are encouraged to send agenda items and additional questions in advance to the meeting facilitator. OCFS intends to join a portion of each meeting, to answer questions and provide updates to the field. Dates: 1/30, 4/10, 7/24 & 10/23

Legally Exempt Workgroup

Legally Exempt (LE) staff work with all providers to support their work caring for children. This workgroup will provide guidance on the development of a series of short trainings that will be developed to deepen LE provider understanding of ACEs, the Protective Factors Framework and traumaresponsive approaches. This group will meet quarterly. Dates: 1/29, 5/7, 9/3 & 12/3

Standards of Excellence

This group is for those working on the Standards of Excellence (SOE) application or 18-month check-in process. In 2025, the group will meet five times for two hours to take a deep dive into embedding DEIB principles and strategies into the existing application standards. There is also an opportunity to collaborate and share resources, discuss challenges that have arisen and explore the Sharepoint submission site. Dates: 3/19, 4/9, 6/26, 8/28 & 11/20
